Mr. Dwyer has represented insurers in insurance coverage disputes in federal and state courts and before the Rhode Island Supreme Court.

Attorney Dwyer regularly litigates cases and counsels clients on patient confidentiality issues, including claims asserted pursuant to the Health Insurance Portability and Accountability Act (HIPAA) and associated state law confidentiality and privacy statutes. He routinely counsels clients on healthcare privilege issues, including those recognized under state law and the federal Patient Safety and Quality Improvement Act, and represents clients before trial and appellate courts to preserve those protections. Mr. Dwyer has advised healthcare clients in establishing Patient Safety Organizations and creating internal Patient Safety Evaluation Systems in accordance with the Patient Safety and Quality Improvement Act.
